1. A child will be considered for acceptance into the school only after the Application for Re-Admission is fully completed, signed and all necessary documents required have been submitted together. Any outstanding documents will result in a delay in admission to the school or losing enrollment spot.
2. I /We will follow and adhere to the policies set in the illness and Health Policy for the benefit of all children and families who attend the school. I/We understand that my child cannot attend school if they have a communicable disease or show signs of fever, diarrhea, vomiting, etc as outlined illness policy.
3. I /We will come and pick up my child should he/she become ill, vomits, develops fever or has diarrhea. I/We will do our best to come within a reasonable time frame to pick them up from the classroom. I/We understand that my child may need to be isolated until an authorized person arrives.
4. There are no refunds for **statutory holidays, sick days, communicable disease/illness outbreaks, Teacher Professional Development Days (PD Days)** or days missed for any other reason throughout the school year.
5. The school is closed for two weeks over the winter holiday (December/January) and one week in March or April, aligning with the regional public school calendar. AVM offers camp during these breaks as optional attendance. **Camps are not included in the regular tuition fee and are at an additional charge.**
6. If there is a change in schedule, either **increasing or decreasing hours**, a change in fee structure will be governed by the Fee Schedule in effect at the time of change and not by the fee structure paid at the time of re-admission. Note that any new policies or updates, once finalized, and will supersede any previous policies.
7. A charge of **\$75 will be levied against an NSF fees or fees returned** to the school for any reason and for payments made after the 3rd of the month.
8. Complete uniforms are **Mandatory** from Monday – Thursday, September to June. Fridays are casual days. Correct Uniform must be adhered to. All extra clothing left at school needs to be solid school uniform colours (Navy Blue, Dark Grey and White. No prints).
9. In the event that a child is withdrawn during the school year, **written notice of withdrawal must be received by administration sixty day's prior to the intended date of withdrawal or sixty day's fee in lieu of notice shall be paid after a child leaves the school, regardless of reason for withdrawal. I/We understand that there will be no refund of the registration fee and of the last month's deposit if withdrawing mid year.** Last month deposit is for the month of June as the end of the term and can not be applied to another month if withdrawing early. If I/we choose to return back to Angus Valley Montessori, I/we agree that my child will be registered as a new student.
10. **This is to confirm:** Emergency Contact, Pick-Up and Release, Parent Information must be updated with school in the event my child's information changes during the school term, I/we are required to make these changes on the child's Procure profile and inform the office via email regarding these changes. I/We understand that only pre-authorized adults may pick up my child and underage siblings are not allowed to pick up the child alone without an adult present

- 11. I/We understand that any aggressive, threatening, discriminatory behaviour etc, towards any Angus Valley Montessori Milton staff, employee or student, will not be tolerated and will lead to disciplinary action up to and including immediate dismissal.
- 12. I/We understand that if my child remains on school campus past the their scheduled pickup time, there will be a late charge of \$2 per minute. Late fees will be due with the following months fees. If your child remains at school past closing time, a late fee of \$5 per minute will be charged.
- 13. **Casa admission is based on Supervisor/Director discretion. I /We understand that a child will only be considered for admission for Casa if he/she is at least 3 years of age and is "fully toilet trained".**  
 I confirm my child is fully toilet trained/ will be fully trained by the time they enroll in Casa.
- 14. Angus Valley Montessori School reserves the right to **accept or reject an Application Re-Admission and/or request the withdrawal of a child at any time**, if it is in the opinion of the Supervisor/Director and/or Teacher that the action is beneficial to the child or the children in the classroom as a whole.
- 15. The administration must receive the signed Re-Admission forms and registration fees in order for enrollment to be confirmed, along with deposit for 2026 and the registration fee.
- 16. I/We agree to adhere to the safe arrival policy and notify the school in writing if there are any changes to expected attendance.
- 17. I/We give permission that in case of an emergency, if I or my spouse or legal guardian is not immediately available, give the staff of Angus Valley Montessori and all persons connected with the school to act on my behalf in case of an emergency to arrange transportation, either by taxi, school vehicle or ambulance to seek medical attention by a nurse or doctor to administer the required emergency treatment.
